TVA Decides Against Retiring Two Units at Its 1,206 MW Coal-Fired Shawnee Fossil Plant in Kentucky

The Tennessee Valley Authority (TVA) announced its decision December 30 to install additional air pollution controls at Shawnee Fossil Plant in Kentucky instead of retiring two units as part of an agreement with the U.S. Environmental Protection Agency. The installations will reduce nitrogen oxide and sulfur dioxide emissions and must be completed by December 2017.

Enbridge Restarts 210,000 b/d North Dakota Pipeline System After Massive Fire at Crude Oil Storage Terminal

Enbridge Inc. restarted its North Dakota system today after a fire at a crude oil storage terminal. The blaze began yesterday at the facility that was leased to its unit, Tidal Energy Marketing. Eight out of 12 crude storage tanks, with a capacity of 400 barrels each, caught fire at the site. As of this afternoon, the flames haven't been extinguished and fire servicemen are trying to put them out. North Dakota Pipeline Co., an Enbridge unit, operates an 826 mile system from Plentywood, Montana, to Clearbrook, Minnesota.
