Update: Fighting Continues in Libya as Saudi Arabia Directs Crude Oil Deliveries to Europe March 3

Pro-Gadhafi forces continued to battle rebel fighters in the oil terminal town of Brega, Libya on March 3, news sources reported, as shipbrokers said Saudi Arabia had moved to compensate for lost oil exports to Europe. Saudi Arabia's Vela International Marine Ltd. directed at least one 1 million barrel tanker to transport crude to the Mediterranean, a shipbroker said. The International Energy Agency (IEA), which said yesterday that Libya's unrest had forced offline between 850,000 and 1 million b/d of crude oil production, said today that the disruption had begun to impact supplies in Europe. The IEA requested approval to release strategic oil inventories, but no country had requested authorization from IEA to release its own reserves, as of latest reports. U.S. crude futures prices dipped on March 3 as the Arab League reported it was attempting to produce a peace accord, but WTI spot prices remained above \$100/barrel, as of latest reports.

CHS Inc. to Expand, Enhance Refined Fuels Supply Infrastructure in Northern Plains, United States

CHS Inc. plans to carry out nearly a dozen projects over the next three years to expand storage capacity at its terminals, improve and expand truck loading facilities, enhance ethanol blending, and streamline loading technology systems, the company said on March 2. Specifically, it expects to:

- Construct a third truck loading rack, install new pumps and piping to increase loading rates by 125 percent, incorporate a more efficient ethanol blending system, and improve efficiency of bill of lading systems at its terminal in Minot, North Dakota. CHS plans to complete those projects between summer 2011 and the end of 2012. Separately at Minot, CHS expects to open two 120,000-barrel fuel storage tanks in fall 2011.
- Upgrade rail car unloading systems, install new pumps and piping to increase truck loading rates by 50 percent, incorporate a more efficient ethanol blending system, and improve efficiency of bill of lading systems at its terminal in Glendive, Montana. It plans to complete those projects between summer 2011 and mid-2012.
- Install two 120,000 barrel storage tanks at its refinery in Laurel, Montana by early 2012.
- Finish replacing nearly 75 percent of its 237-mile Laurel-Glendive, Montana refined fuels pipeline by the end of 2011.

Watco, Kinder Morgan Plan Crude by Rail Network in North Dakota, Oklahoma, and Texas

Watco Companies, LLC and Kinder Morgan Energy Partners, L.P. plan to construct and operate rail transload facilities for loading and unloading crude oil – along with other commodities and products tied to the oil-and-gas industry – in key markets across North Dakota, Oklahoma, and Texas, the companies said on March 1. The network will consist of several key markets including Dore, North Dakota, Stanley, North Dakota, Stroud, Oklahoma, Houston, Texas, and several strategic loading facilities in the Eagle Ford Shale area in south Texas. The Dore, North Dakota facility is expected to begin operations on September 1, 2011. The Stroud, Oklahoma facility is scheduled to open on October 1, 2011.
