### Exelon's 802 MW Three Mile Island Nuke Unit 1 in Pennsylvania Shut March 4

Operators shut the unit to fix small leaks on two reactor coolant pumps, a news source said. #### SCE Postpones Restart of 1,070 MW San Onofre Nuke Unit 2 in California

Southern California Edison (SCE) shut the unit for refueling and other work in late September, but expected to restart it by late December, a news source said. The source did not say why the unit had failed to restart for so long, but did say that operators delayed the restart last week after issues during testing, according to a Nuclear Regulatory Commission (NRC) spokesman.

#### Aging Workers at Issue as Nuclear Power Sector Faces Labor Shortfall

Companies have proposed, or are considering, some 18 commercial nuclear power projects, and the prospect of a labor shortfall—driven by an aging workforce—could pose problems for those plans, according to a news source. To maintain its current workforce, the U.S. nuclear power industry could need to hire up to 25,000 more workers over the next five years, the Nuclear Energy Institute said.

#### Update: BP to Break Ground on Multiple U.S. Wind Farms in 2010 and 2011

BP plans to begin construction at the end of the first quarter, 2010, on its planned 124.5 MW Goshen North wind farm in Idaho, according to a news source. The company expects to open the facility later in the year, according to a news source. Separately, BP plans to break ground in 2011 on its planned 200 MW Golden Hills I wind farm in Oregon, and its 250 MW Cedar Creek II wind facility in Colorado.

#### Terrorists Seek to Attack Oil Tankers along Malacca Strait—Singapore Navy

The Singapore navy has "received indication" that a terror group with possible links to al-Qaeda is looking to attack oil tankers along the Malacca Strait, it said in an advisory. The Malacca Strait stretches 600 miles, from Malaysia to Sumatra. More than 90,000 vessels traverse it per year—about 15 million b/d moved through it in 2006. Should it shut down, almost half of the world's vessels would need to find alternate paths, according to the Energy Information.

#### Toyota Tsusho Corp. Plans 450,000 b/d, 870-mile South Sudan-to-Kenya Oil Pipeline

The line would connect South Sudanese oil producers to the Lamu port along Kenya's Indian Ocean coast, news sources said. Toyota Tsusho Corp. would operate the line for 20 years, and then cede control to the South Sudanese and Kenyan governments.

#### Williams Launches Open Season for Planned 420,000 Dth/d Expansion along Transco Natural Gas Pipeline in U.S. Northeast March 4

A unit of Williams Partners L.P. launched a binding open season for the "Northeast Supply Link" expansion project along its Transco natural gas pipeline system in the U.S. Northeast, it said in a release. The link would deliver 420,000 Dth/d of natural gas from the Marcellus Shale in Pennsylvania to customers in New York and New Jersey. Pending approval from the Federal Energy Regulatory Commission (FERC), Williams expects to open the project's first, 120,000 Dth/d phase in 2012, and its second phase in November 2013.

## **Repsol's Canaport, New Brunswick LNG Terminal May Double Natural Gas Exports to U.S. New England Region in Winter 2010-2011**

Repsol YPF SA may deliver an average 800 MMcf/d of natural gas, via pipeline, to the U.S. Northeast next winter, up from 400 MMcf/d this winter, a company official said. The plans come as suppliers struggle to keep pace with increasing customer demand along a limited regional pipeline system.

#### Blue Ribbon Commission on America's Nuclear Future to Hold First Meeting March 25-March 26

On Thursday, March 25th and Friday, March 26th, the Blue Ribbon Commission on America's Nuclear Future, cochaired by former Congressman Lee Hamilton and former National Security Advisor General Brent Scowcroft, will hold its first meeting in Washington, D.C, the Department of Energy (DOE) said in a release. At the direction of President Obama, Secretary of Energy Steven Chu established the Blue Ribbon Commission to conduct a comprehensive review of policies for managing the back end of the nuclear fuel cycle and to provide recommendations for developing a safe, long-term solution to managing the Nation's used nuclear fuel and nuclear waste.

# Update: Range Fuels Receives \$80 Million USDA Loan Note Guarantee for Planned 20 MMGal/Yr. Cellulosic Ethanol Plant in Soperton, Georgia

The company expects to begin production in the second quarter of 2010, at a rate of less than 10 MMGal/Yr., according to its website and news releases. The site is permitted to produce 100 MMGal/Yr. of ethanol, but is expected to generate far less product—about 20 MMGal/Yr.—at full operation. The plant will initially use wood from nearby timber operations, and eventually process leftover wood residue.
