PSE&G's 1,096 MW Hope Creek Nuclear Unit 1 in New Jersey Shut for Repairs April 8

Public Service Enterprise Group Inc. (PSE&G) shut unit 1 from full power late Tuesday after one of the two steam generator feed pumps stopped working. The snag led to low water levels inside the steam generators, requiring the manual reactor trip, and troubleshooting was in progress, a company spokesman said. Electricity traders estimated the unit would return to full power in about a week. The company did not give a return date. Reuters, 9:22 April 9, 2014

Appalachian Power Converting Two Units to Natural Gas at Its Clinch River Coal-fired Power Plant in Virginia

The process to convert two units of the Clinch River Power Plant near Carbo, Virginia, from coal-fired to natural gas is underway, while a third unit was retired. The two units that will be converted have nameplate capacities of 238 MW each. Both will burn coal through the summer of 2014 before one unit is taken offline for conversion in the fall of 2015, while the second will be converted in early 2016. Company officials stated that both units will be fully converted by spring of 2016.

U.S. Department of Commerce Approved 52 Oil Re-export Licenses in Last Six Months

The permits, which were approved between October 2013 and March 2014, included 14 licenses for re-exports to European countries, according to data released by the department's Bureau of Industry and Security.

U.S. Gulf Coast Crude Oil Stocks Hit Record High Last Week – EIA

U.S. Gulf Coast crude oil stocks rose 3 million barrels last week to their highest level on records going back to 1990, weekly data from the U.S. Energy Information Administration (EIA) showed on Wednesday. Oil stocks in the region hit 202 million barrels, even as refinery utilization rose by 1.6 percentage points to 91.3 percent, the data showed.

Update: Libyan Oil Guards Take Control of Hariga Port, Zueitina Port Handover Pending

An agreement over the weekend opened the two eastern ports and marked the beginning of the end of the nine-month blockade of major oil terminals by a federalist rebel group.
