NRC Faces Challenges amid Surge in Nuclear Power Plant Applications

The U.S. Nuclear Regulatory Commission (NRC) faces a surge in nuclear power applications – the agency is reviewing 13 proposals, and companies have withdrawn or delayed another five – and challenges in working through its newly-instituted "combined operating license program," according to a senior agency official. The "combined" program enables the NRC to simultaneously authorize the construction and operation of nuclear power plants. Companies had, prior to the program, applied for the licenses separately.

Update: Progress Energy Carolinas Plans 600 MW Gas-Fired Power Plant in North Carolina – Piedmont Natural Gas to Construct Associated 133-Mile Pipeline

Progress Energy Carolinas plans to shutter its 600 MW coal-fired Sutton power plant in North Carolina and replace the facility with a 600 MW gas-fired power plant, according to multiple company releases. It aims to retire the coal-fired units in 2014, and expects the gas-fired units to be ready at that time. Piedmont Natural Gas plans to supply the new facility via a 133-mile natural gas pipeline. It plans to break ground on the pipeline in early 2011 and complete the work in June 2013.

Shell Shuts 115,000 b/d EA Oilfield Offshore Nigeria for Repairs by April 15

Shell shut the East Area (EA) field to repair equipment related to the floating, production, storage and offloading unit, according to THISDAY. The field can produce 115,000 b/d of oil, but a Shell spokesman – despite confirming a complete shutdown - said the disruption had only impacted 100,000 b/d. The reason for the discrepancy was not clear, based on available news sources.
