Major Developments

Storms Knock Out Power to Nearly 500,000 Customers across Central United States April 19-20

Storms blasted the central United States on April 19-20, knocking out power to an estimated 497,987 customers across multiple states, news and company sources reported. The storms were expected to impact the eastern United States, as of latest reports. Multiple states reported outages, but the following table lists only those states where 10,000 or more customers lost electricity, based on available data.

Update: Citing Japanese Disaster, NRG Energy Drops Plans to Pursue Two-Unit, 2,700 MW Nuclear Power Expansion at Existing Facility in South Texas

Citing "the diminished prospects for the South Texas Project nuclear development project as a result of the ongoing nuclear incident in Japan," NRG said yesterday that it would write down its investment in the project and stop investing funds in the development effort. The company, along with Toshiba, had planned to construct two units – generating a combined 2,700 MW of electricity – at the existing South Texas nuclear facility in Texas. NRG said it could pursue the project if the situation changed, but the company's chief executive said that the chances of that happening were "extremely daunting and at this point not particularly likely."

The Nuclear Regulatory Commission and the U.S. Army Corps of Engineers, Charleston District, issued a Final Environmental Impact Statement (FEIS) in apparent support of the project, concluding that were no environmental impacts to preclude issuing South Carolina Electric & Gas (SCE&G) Combined Licenses to construct and operate the new units. SCE&G plans to construct two 1,100 MW units.

FCC Shuts at ExxonMobil's 238,600 b/d Joliet, Illinois Refinery by April 20

A gasoline-producing fluid catalytic cracking (FCC) unit shut for unknown reasons by April 20, ExxonMobil said in a filing with state regulators. The incident led to emissions and the company was "in the process of troubleshooting the unit to get it restarted," according to the filing.

Sunoco restarted a 90,000 b/d gasoline-making fluid catalytic cracking (FCC) unit on April 20, sources familiar with the facility's operations said, after a fire forced shut the unit last week. The company expected the FCC to resume production tomorrow, the sources said.

Update: Ecopetrol Sees No Impact to Exports or Production after Weekend Attack along 220,000 b/d Cano Limon-Covenas Oil Pipeline in Colombia

Attackers blew up a portion of the pipeline over the weekend, but the line was not delivering oil when the attack occurred and the incident did not impact production or exports, according to source with Ecopetrol, Colombia's state-run oil company. The 480-mile pipeline is designed to deliver as much as 220,000 b/d, but typically transports approximately 80,000 b/d.

Citing Changing Market, Excelerate Energy to Retire Deepwater LNG Import Facility in Gulf of Mexico

Citing "the changing market for liquefied natural gas (LNG) imports into the U.S. Gulf Coast," Excelerate Energy said recently that it planned to retire its Gulf Gateway Energy Bridge Deepwater Port LNG import facility. Gulf Gateway was the world's first deepwater LNG import facility. It is located 116 miles offshore and is equipped to deliver up to 690 MMcf/d of natural gas. Excelerate expects to remove the facility within 68 days of permit approval.
