PSEG to Consider Fourth Nuclear Reactor alongside Salem and Hope Creek Power Plants in New Jersey

Public Service Enterprise Group (PSEG) will consider, in the "longer term," adding a fourth nuclear unit to its Salem and Hope Creek nuclear power complex, the company's Chairman and Chief Executive said April 21. The existing facility consists of three nuclear reactors—the 1,170 MW Salem 1, the 1,170 MW Salem 2, and the 1,170 MW Hope Creek. The Hope Creek site was designed to house an additional reactor. Pipeline Leak Slows Marathon's 226,000 b/d Catlettsburg, Kentucky Refinery April 17

Marathon's 226,000 b/d Catlettsburg, Kentucky refinery has run at reduced rates since April 17 due to a leak along an associated oil pipeline, the company said today. A leak forced shut the 24-inch Owensboro-to-Catlettsburg pipeline by April 17; operators restarted the line at reduced capacity yesterday, Marathon said. The company did not provide a timetable for full restoration, but said it had "implemented an allocation to customers within the area." DJN, 12:21 April 21, 2009

Update: Total Plans Steam Boiler Restart at 232,000 b/d Port Arthur, Texas Refinery April 20—Company Shut Entire Refinery in March, Citing Economic Conditions

Total shut down Port Arthur's main processing units on March 24 due to "dire" economic conditions. According to a filing with state regulators, Total said it planned to restart a steam boiler yesterday,. A spokeswoman declined to say whether the company expected to restart the entire facility, but did note a more-positive environment at Port Arthur. The company has used the facility-wide shutdown to advance a multi-billion dollar production and processing expansion plan, according to a news source. Total plans to install a 50,000 b/d coking unit, a vacuum distillation unit, and a sulfur recovery unit by 2011.

Exxon Mobil Repairs Wet Gas Compressor at 567,000 b/d Baytown, Texas Refinery by April 20

The company shut the wet gas compressor, associated with a gasoline-producing fluid catalytic cracker (FCC), due to a leak on April 19. Operators completed repairs and restarted the unit. Iraq Looks to Restart 300,000 b/d Iraq-to-Syria Oil Pipeline

Iraq is soliciting bids from foreign companies to restore a 300,000 b/d Iraq-to-Syria oil pipeline, an Oil Ministry spokesman said on April 21. U.S. forces bombed the Iraqi side of the line during the 2003 invasion. A Russian company signed a deal to restart the line last year, but did not follow through on its plans, the Iraqi spokesman said. Update: Saudi Aramco Postpones Planned 900,000 b/d Moneefa Offshore Oil Project by at Least Six Months

Saudi Aramco expects to open the 900,000 b/d Moneefa offshore oilfield in 2012, at least six months later than its originally-scheduled mid-2011 opening, industry sources said. The state-oil company put the project under review in November 2008, seeking to renegotiate contracts and account for declining construction costs stemming fror changing economic conditions. Aramco expects to break ground on oil processing facilities in January 2010, according to a contractor. The field would be Saudi Arabia's largest-ever offshore oil project. It would not, however, boost the nation's production capacity; instead, it would compensate for declining output elsewhere. Reuters, 12:35 April 20, 2009

Gunmen attacked a Total-chartered Turkish oil vessel offshore Nigeria on April 21, kidnapping the captain and an engineer, according to private security sources. The "Ilena Mercan" was en route to the Onne port in southeast Nigeria.

Update: Algonquin Gas Transmission Restarts Hubline Natural Gas Pipeline from Northeast Gateway LNG Terminal Offshore Massachusetts by April 20

Algonquin Gas Transmission restarted its Hubline natural gas pipeline by April 20 after an outage lasting nearly three months, the company said in a notice. The line delivers natural gas from the Northeast Gateway LNG terminal to Algonquin's onshore pipeline system. It had been shut since at least January 14 due to a blockage; Excelerate Energy's Explorer LNG tanker had been anchored at the terminal since that date, awaiting repairs to the line. The tanker was expected to offload approximately 120 MMcf of regasified LNG into the pipeline today. Reuters, 11:22 April 21, 2009

Maritimes & Northeast Pipeline Requests FERC Approval to Export Natural Gas from United States to Canada

Maritimes & Northeast Pipeline asked the Federal Energy Regulatory Commission (FERC) for approval to export natural gas from the United States to Canada, a news source said. The plan would not involve any new construction. Instead, the company would employ its existing, 833,000 Dth/d cross-border facility. The Maritimes & Northeast pipeline system stretches from Nova Scotia, Canada to the U.S. border, then south through Maine, New Hampshire and Massachusetts.
