Update: Deepwater Horizon Oil Rig Sinks in Gulf of Mexico April 22: Coast Guard – Search Continues for 11 Missing Workers

The Transocean owned-and-operated Deepwater Horizon oil rig sunk into the Gulf of Mexico at 10:20 AM on April 22, a Coast Guard spokesman said. The incident came 36 hours after an explosion onboard injured at least 17 and left another 11 missing. The Coast Guard's website had not confirmed the sinking, as of latest reports. The most recent Coast Guard posting, however, said the fire was still burning. The rig was leaking about 8,000 b/d of oil, and the Coast Guard was preparing for it to leak as much as 700,000 gallons of diesel fuel, according to a Coast Guard Petty Officer. A pressure surge – or blowout – may have been to blame for the explosion and subsequent fire, a Transocean official said on April 21. "There was undoubtedly some abnormal pressure buildup," he said. Update: Exelon's 855 MW Quad Cities Nuclear Unit 2 in Illinois Ramped Up to 99 Percent by April 22

The unit shut for planned reasons in mid-March, according to Bloomberg News. Operators began restarting the unit by mid-April, but halted that effort on April 16 due to a higher temperature in a turbine bearing. Update: FPL Restarts 839 MW Saint Lucie Nuclear Unit 2 in Florida

FPL returned the unit to 2 percent power by this morning, April 22, according to a Nuclear Regulatory Commission report. The company shut the unit "due to lifting of the 2B moisture separator reheater relief valve," it said in a previous filing with the NRC. Update: With Eye on New State Law, Xcel Evaluating Colorado Coal-Fired Power Plants for Shutdowns or Conversions

Xcel Energy must, under new state law, submit plans in August to cut nitrogen dioxide emissions from its coal-fired power units by as much as 80 percent – compared to 2008 totals – by 2017. With that law in mind, the company is considering retiring or converting to natural gas several of its existing coal-fired power facilities. The potential coalfired sites include: four units with a combined 717 MW of capacity at the Cherokee power plant, a 505 MW unit at the Pawnee plant, and a 186 MW unit at the Valmont plant. http://www.reuters.com/article/idUSN2010698620100420

Department of Interior Issues Request for Interest in Renewable Energy Development Offshore Delaware

The Department of the Interior referred to the move as "the first step for leasing a wind energy project on the Outer Continental Shelf." Bluewater Wind Delaware, LLC has already received state approval for its plan to generate up to 200 MW of wind-based power offshore Delaware, but the company must still apply to the Minerals Management Service (MMS) for an offshore lease. The Request for Interest covers federal waters between the shipping routes for the Delaware Bay. The closest point to shore is about 7.5 miles.

Update: BP Restarting Units after Steam System Malfunction at 467,720 b/d Texas City, **Texas Refinerv**

BP began "restarting a couple of units" after a steam system snag at its 467,720 b/d Texas City, Texas refinery, a company spokesman said on April 21. The spokesman referred to the incident as "pretty short-lived," but did not say which units were affected. A source familiar with the site's operations, separately, said that the facility had resumed normal operations by April 22.

Bomb Attack Forces Shut Iraq-to-Turkey Oil Pipeline by April 22

Unknown assailants bombed and forced shut the Kirkuk, Iraq-to-Ceyhan, Turkey oil pipeline by April 22, according to police and oil company officials. North Oil Co. expected to complete repairs and resume exports within one week. The line can deliver up to 1.6 million b/d of oil, but throughput was far less – about 450,000 b/d – over the first three months of 2010. Reuters said.

ONEOK Partners, L.P. Plans Multiple Natural Gas Projects in North Dakota and Oklahoma

ONEOK Partners plans to spend about \$405-470 million through 2011 on projects in the Bakken Shale in the Williston Basin of North Dakota and the Woodford Shale in Oklahoma.

In the Bakken Shale, the company plans to:

- Construct the 100 MMcf/d Garden Creek natural gas processing plant in McKenzie County, North Dakota. It expects to complete the project in the fourth quarter of 2011.
- Expand and upgrade existing natural gas gathering system.

• Connect more than 300 wells in 2010 and about 400 wells in 2011 to its Williston Basin gathering system. In the Woodford Shale of Oklahoma, the company plans to:

- Connect its Oklahoma natural gas gathering system to its existing Maysville natural gas processing facility in the central part of the state. The company aims to complete the work during the fourth quarter of 2010.
- Connect new wells in 2010 and 2011.
- Complete a new natural gas processing plant in the fourth quarter of 2010 and expand its existing natural gas liquids (NGLs) gathering system to accommodate the new plant.

The move should enable DOE to provide \$2 billion grants to two projects: USEC's proposed facility in Piketon, Ohio and Areva's planned site in Idaho.
