#### Update: Nearly 40,000 Customers Remain Without Power in Missouri and Illinois May 12

An estimated 28,924 Ameren customers in Illinois and 11,000 Missouri Electric Cooperatives customers in Missouri remained without power today, May 12, the companies reported. Storms knocked out power to more than 300,000 customers in the U.S. Midwest over the weekend. Ameren expected to restore power to most affected customers by late tonight. Scattered outages remained among several utilities in Missouri, Kansas, and Kentucky, according to multiple reports.

#### Update: Southern's 857 MW Hatch Nuke Unit 1 Shuts During Restart by May 11

Southern's 857 MW Hatch nuke unit 1 shut by May 4 due to a malfunctioning valve, but operators returned it to 1 percent power by May 8. The unit, however, shut again by yesterday, May 11, according to a report filed with the Nuclear Regulatory Commission (NRC). Traders were unsure whether the unit exited the outage before the second shutdown.

#### Ultracracker Upset at BP's 467,720 b/d Texas City, Texas Refinery May 11

A cooling system leak triggered an ultracracker upset and flaring at BP's 467,720 b/d Texas City, Texas refinery on May 11, the company said in a filing with state regulators. The incident forced operators to shut the unit for repairs, according to sources familiar with the facility's operations. Sources did not say if the refinery was running at reduced rates.

#### Total Slows Units after Malfunction at 232,000 b/d Port Arthur, Texas Refinery May 11

Total slowed a gasoline-making fluid catalytic cracking unit (FCC) and a diesel hydrotreater after a Shell Claus offgas treating (SCOT) unit malfunctioned on May 11, according to a filing with state regulators. Separately at Port Arthur, three workers were taken to the hospital due to shortness of breath on May 12, local news reported. A Total spokesman said the company was investigating a possible leak.

#### Update: Power Back at Shell's 329,800 b/d Deer Park, Texas Refinery by May 12

Shell planned to begin restarting units today at its 329,800 b/d Deer Park. Texas refinery, one day after a power failure shut an associated, Calpine-owned steam plant, the company said in a filing with state regulators. Shell expected to return the refinery to normal production "sometime over the next several days," according to a statement. Sources did not indicate the extent of the disruption.

#### Update: Valero Expects 182,200 b/d Delaware City, Delaware Refinery at Planned Rates by **End of May**

Valero said it would return its Delaware City, Delaware refinery to normal rates by the end of May, or more than two months after operators shut the facility for coker and other repairs. The company has already restarted a crude unit, a fluid catalytic cracker and a hydrocracker, according to a spokesman. Those units are moving toward planned rates.

#### Update: Irving Oil Completes Unplanned FCC Work at 300,000 b/d Saint John, New **Brunswick Refinerv by May 12**

Irving Oil said it expected to return the resid fluid catalytic cracking unit (FCC) to normal service soon at its 300,000 b/d Saint John refinery in New Brunswick, Canada. #### Ivanhoe Energy Eves 50,000 b/d Production at Tamarack Oil Sands Project in Alberta, Canada

The Tamarack oil sands project in Alberta. Canada holds an estimated 441 million barrels of recoverable oil. according to Ivanhoe Energy. That would enable the field to produce 50,000 b/d of oil for 30 years, the company said.

#### Iraq Plans 30,000 b/d Boost at 100,000 b/d Bazargan Oilfield

The U.S. company Weatherford received a contract to drill 20 wells in Iraq's Bazargan oilfield, according to an official with the state-run Maysan Oil Company. The official said the project could increase production by 30,000 b/d from the current 100,000 b/d level.

#### El Paso Shuts Portion of 24-inch Southern Natural Gas Co. Pipeline in Alabama

El Paso Corp's Southern Natural Gas Co. took a section of its 24-inch north main line in Alabama offline for repairs by May 11, it said on its website. The company said it planned to restart the line late this week. It did not expect the disruption to affect firm transportation but noted that interruptible service and peak hourly capacity could be impacted. The Southern Natural Gas pipeline system stretches 7,600 miles; it is part of El Paso's 42,000-mile interstate network. Reuters, 13:29 May 11, 2009

Sabine Declares Force Majeure along Natural Gas Pipeline in Port Neches, Texas May 12

Sabine Pipe Line LLC declared force majeure after "mechanical problems" forced it to shut a compressor unit in Port Neches, Texas, it said in a Web site posting. A coal-carrying train derailed near Washington, Missouri early on May 12, dumping an unspecified quantity of coal and disrupting rail traffic along the Missouri River, a news source reported. An estimated 23 cars jumped the tracks, but no one appeared to have been injured. The coal was en route to Ohio, slated for delivery to the American Electric Power Company.
