#### Storms in Alabama Down Utility Lines, Knock Out Power to 45,000 Customers August 3-4

Athens Utilities reported a peak of 25,000 Alabama customers without power after storms hit the area. Huntsville Utilities also reported a peak of 20,000 Alabama customers without power. As of latest reports, 11,000 Huntsville Utilities customers are still in the dark.

#### Multiple Thunderstorms Knock Out Power to Peak of About 20,000 Kansas Customers August 3-4

News reports indicated that a peak of about 20,000 Westar Energy customers lost power in Kansas amid thunderstorms and high winds. As of latest reports, 8,442 customers are still in the dark. The company reported the morning of August 3 that a total of at least 47,081 customers had lost power at one point during the storms, though the company said that this number does not reflect peak outages, and that it includes some customers who were double-counted due to losing power multiple times.

### **Update: Operators Retract July 16 NRC Notification Regarding Loss of Computers at SCE's San Onofre Nuclear Plant in California August 4**

On July 16, operators of the plant filed a report with the Nuclear Regulatory Commission (NRC) reporting an unusual event "due to safeguards system degradation related to access to protected and vital areas of the plant." #### UGI's 125 MW Hunlock Gas-Fired Power Plant in Pennsylvania Shut by July 28

According to the company, a failure in the heat recovery steam generator in one of the plant's two gas-fired units led to a shutdown of the entire plant. Operators are inspecting the 65 MW unit 6 to see if it was damaged in the event. The plant's other unit, the 60 MW unit 5, was not damaged in the incident. However, unit 5 was also shut down as a precautionary measure.

### Pembina Places 100,000 b/d Nipisi Heavy Oil and 22,000 b/d Mitsue Diluent Pipelines into Service in Alberta by August 3

The Nipisi pipeline is a new 118-mile (190-kilometer), 100,000 b/d heavy oil pipeline which will run from north of Slave Lake to Pembina's existing pipeline south of Swan Hills and on to Edmonton. It has the potential to be expanded to 200,000 b/d. The 22,000 b/d Mitsue pipeline will transport condensate from various sources in Alberta to heavy oil producers operating north of Slave Lake for use by producers to dilute heavy oil prior to transport. It consists of about 84 miles (135 kilometers) of new pipeline and about 75 miles (120 kilometers) of existing pipeline. It has the potential to be expanded to 45,000 b/d.

### Plains All American Announces Completion of 100,000 b/d Expansion at 320,000 b/d Mesa Pipeline System in Texas by August 4

The company announced that it recently increased the available throughput capacity of its 80-mile Mesa Pipeline System by approximately 100,000 b/d to approximately 420,000 b/d. The pipeline system is jointly owned by subsidiaries of Plains All American and Sunoco Logistics.

### BakkenLink LLC Scales Back Plans for Proposed Oil Pipeline in North Dakota Due to Uncertainty Surrounding TransCanada's Proposed Keystone XL Pipeline August 3

The BakkenLink pipeline was originally planned to carry up to 100,000 b/d 250 miles from North Dakota to Baker, Montana. However, the project has now been scaled down to 144 miles, entirely within North Dakota, due to construction uncertainties related to TransCanada's proposed Keystone XL pipeline. ### Musket Announces Construction Begins on Capacity Expansion at Dore, North Dakota Crude-by-Rail Facility August 1

Construction began on August 1 on a high-speed loading facility capable of moving unit trains of crude oil from the Bakken Shale/Williston Basin to markets across the country. Additions to the facility include a loading rack for unit trains, fixed tanks, and a pipeline connection. The facility will have a total outbound capacity of 70,000 b/d when it is complete, planned for the first quarter of 2012.

#### Apache Reports Production Increased by 102,000 Boe/d over Past Year August 4

The company reported production levels of 749,000 boe/d for the three-month period ending June 30, 2011. During the same period in 2010, production was 647,000 boe/d. Apache reported that the following projects completed during the last quarter contributed towards the company's overall production increase:

- Apache commenced production from its most prolific development well in the Forties field in the North Sea, which came online in excess of 12,500 b/d of oil.
- The company also drilled five new field discoveries in the Faghur basin in Egypt. In aggregate, the wells tested at rates exceeding 12,000 b/d of oil and 19 MMcf/d of natural gas.
