### Windstorms, Possible Tornadoes Cut Power to Nearly 120,000 Customers in Ontario, Canada August 20—About 15,000 Remain in the Dark August 21

Severe windstorms and at least four possible tornadoes knocked out electricity to 69,000 Hydro One customers, 25,000 Veridian Connections Inc. customers, and 25,000 Toronto Hydro customers on August 20. The storms killed at least one person. Just 7,622 Hydro One customers, 4,500 Toronto Hydro customers, and 3,000 Veridian Connections customers remained without power, as of latest reports.

#### PGE Completes 150 MW Expansion at Biglow Canyon Wind Farm in Oregon

Portland General Electric (PGE) completed the 150 MW, Phase 2 expansion of its existing 125 MW Biglow Canyon Wind Farm, boosting the facility's output to 275 MW, the company said in a release. PGE plans to open an additional 175 MW in 2010.

## Epcor Plans 270 MW and 150 MW Units at Existing Genesee Coal-fired Power Plant in Alberta, Canada

Epcor plans to construct a 270 MW Integrated Gasification Combined Cycle (IGCC) power unit and a 150 MW amine scrubbing combustion facility at its Genesee coal-fired power plant in Alberta, Canada, according to a news source. The company also hopes to expand an existing, associated coal mine: a 5.4 million tonnes/year site that feeds the facility's existing power units. At its current pace, the mine will run out of coal in 15 years. The expansion would increase its area by 55 percent.

## Update: Obama Administration Okays Enbridge's Proposed 800,000 b/d, 1,000-mile Alberta, Canada-to-Wisconsin Alberta Clipper Oil Sands Pipeline

The Obama administration approved the U.S. section of Enbridge Energy's planned 800,000 b/d, 1,000-mile Alberta-to-Wisconsin oil sands pipeline, and Enbridge said it had begun mobilizing construction workers to break ground. The line should open in about one year, with an initial capacity of 450,000 b/d.

# ExxonMobil Canada Evacuates Natural Gas Workers from offshore Nova Scotia ahead of Hurricane Bill August 19

ExxonMobil evacuated some workers from its five-platform, natural gas-producing Sable Offshore Energy Project on August 19, and planned to remove its remaining employees ahead of Hurricane Bill. The company said the evacuations would not impact production; Sable had already been offline for planned work. The National Hurricane Center expects Hurricane Bill, currently a Category 3 storm, to hit Nova Scotia over the weekend.

### American Energy Enterprises Plans 80-100 MMGal/Yr. Cellulosic Ethanol Plant in Connecticut

American Energy Enterprises expects to begin production at a rate of 15 million gallons/year (MMGal/Yr.) in mid-2010, and eventually boost production to 80-to-100 MMGal/Yr. The facility would produce low-cost ethanol—at rates less than \$1/gallon—by obtaining unwanted wood waste from nearby landfills for free, or at a profit, a company official said. The landfills, at present, pay tipping fees of up to \$60/ton to get rid of wood waste. http://www.ethanolproducer.com/article.jsp?article\_id=5922

#### Dynamic Fuels Plans 75 MMGal/Yr. Synthetic Diesel Plant in Louisiana
