### Lock Break on Ohio River in Kentucky Shuts Barge Traffic September 27

According to the Army Corps of Engineers (ACE), barge traffic was stopped in both directions at about 9 AM EDT. An auxiliary lock was set up to start allowing some barge traffic by 8 PM EDT. ACE has not determined the cause of the lock break. A lock is a section of a waterway closed off with gates to allow vessels to adjust to water elevation changes. About 55 million tons of commodities are transported through that lock each year, coal for power plant being the main commodity. Most coal-fired power plants typically have a 30-day supply of coal on site in case of supply disruptions.

### Oil Tanker Runs Aground, Halts Vessel Traffic in Lower Mississippi River September 28

An oil tanker carrying approximately 474,000 barrels of crude ran aground, blocking traffic to deep draft ships. The US Coast Guard has four tugboats working to free the tanker. Crude from the tanker was being transported to ExxonMobil's 190,000 b/d Chalmette, Louisiana Refinery.
