Snow Storm Knocks Out Power to 25,000 Allegheny Power Customers in Pennsylvania over Weekend

An early season snowstorm downed power lines over the weekend. Allegheny Power reported about 900 residents remain without power as of Sunday, and some customers were not expected to have power restored until sometime today.

FPL and Progress Energy to Develop New Nuclear Power Facilities in Florida

The Florida Publics Service Commission reported that FPL and Progress Energy will collect more from ratepayers as a down payment to develop nuclear power in the state. FPL is planning construction of two nuclear reactors, Turkey Point Units 6 and 7, and work on increasing output at its existing units, Turkey Point Units 3 and 4 and St. Lucie Units 1 and 2. Progress Energy is proposing construction of Levy Units 1 and 2 and expanding output at its existing Crystal River facility. FPL plans on adding 2,614 MW and Progress Energy plans on adding 2,380 MW of new nuclear generated power. California Governor Signs Legislation to Allow 800 MW CPV Sentinel Gas-fired Power **Project to Move Forward**

The Sentinel Power Project is a joint venture by Competitive Power Ventures and GE Energy, and will be developed near 600 MW of operational wind power and 150 MW of wind power under development. The legislation allows the required emission credits to be transferred to the project.
