Companies Plan Nearly 70 GW of Renewable Energy Projects in California

Companies have proposed 244 renewable power projects in California, totaling nearly 70 GW in potential output, Governor Arnold Schwarzenegger said on December 29. About 50 of those projects aim to begin construction by the end of 2010. Xcel Energy Plans to Boost Wind Power Capacity by 3,000 MW in Minnesota or Wisconsin—Company Eyes Renewable Growth throughout Service Territory

Xcel Energy plans to buy or construct 3,000 MW of wind power capacity in Minnesota or Wisconsin, and expects to increase its system-wide wind output to 7,000 MW—from the current 2,800 MW—by 2020, according to a news source. The company also aims to boost its solar power capacity by 200-to-600 MW by 2020, convert its coal-fired Black Dog power plant in Minnesota to run on natural gas, and shutter two coal-fired power facilities in Colorado. Xcel serves customers in Colorado, Minnesota, Wisconsin, Michigan, North Dakota, South Dakota, New Mexico, and Texas, according to its website.

Update: Allegheny Energy, AEP See Less Immediate Need for Planned 765-kV, 275-mile, West Virginia-to-Maryland PATH Transmission Line

Allegheny Energy and American Electric Power (AEP) might not need to construct the proposed Potomac-Appalachian Transmission Highline (PATH) by 2014, as previously thought, the companies said in a press release. The project "appears not to be needed in 2014 to resolve reliability problems on the electric grid," based on preliminary data from PJM Interconnection, the regional grid operator, AEP and Allegheny said. Citing that data, the companies requested permission from Virginia regulators—as they previously said they would—to withdraw an earlier-filed application for that state's portion of the line. PJM's more-comprehensive "2010 Regional Transmission Expansion Plan," slated for later release, "will identify an in-service date," the companies said.
