Major Developments

Winds, Rain Knock Out Power to Almost 400,000 Customers across U.S. Southeast/Mid-Atlantic February 24-25

Winds and rain blasted the U.S. Southeast and U.S. Mid-Atlantic on February 24-25, knocking out power to an estimated 397,000 customers across multiple states, news and company sources reported. The following table lists peak and current outage figures, based on latest available data.

Most Ports Offline as Unrest Forces Shut up to 1 Million b/d of Oil Production in Libya February 24-25

Unrest forced shut between 500,000 b/d and 1 million b/d of oil production in Libya by February 24, and the nation's ports were mostly offline by February 25, according to analyst estimates and industry sources. Libya typically produces approximately 1.6 million b/d of oil. At least one major Libyan oilfield – Amal – remained in production, according to a field official. Rebels had taken control of multiple oil and oil product terminals by February 24, locals said. Shipping sources, meanwhile, said today that the turmoil had stalled at least five tankers, or about 3 million barrels of oil. "You can't get into those ports. There is zero communication," according to one industry source. "We've heard reports of vessels turning around." Refiners, for their part, were turning elsewhere for crude supplies: companies were looking to purchase crude from ports in West Africa and Ceyhan, Turkey, according to a Teekay Tankers official. Eni, Total, OMV, and Repsol had all halted or curtailed oil production, as of latest reports. Sources said Eni was likely to reduce its output further and could be forced to completely stop production. President Obama, separately, said oil reserves and excess capacity in other oil-producing nations would give the United States the ability "to ride out the Libya situation."

The projects represent more than 872 MW of proposed power production. They include: four wind projects totaling 615 MW, 35 solar projects totaling 257 MW, and one 500 KW water project.

Update: Power Failure Knocks Offline Multiple Units at Imperial Oil's 121,000 b/d Sarnia, Ontario Refinery February 24

A power failure forced shut multiple operational units and led to a chemical release that burned at least one worker at Imperial Oil's 121,000 b/d Sarnia, Ontario refinery on February 24, news and company sources reported. The power outage occurred at about 10 AM local time. The company was working to restart the affected units within less than two hours.

OPEC Oil Exports to Dip on Reduced Demand in Four Weeks to March 12: Oil Movements

The Organization of Petroleum Exporting Countries (OPEC) will load 23.88 million b/d of crude in the four weeks ending on March 12, compared to 24.19 million b/d in the four weeks to February 12, Oil Movements said on February 24. The total does not include Angola and Ecuador. Oil Movements blamed the decline on reduced demand and refinery maintenance. Update: CPUC Considers Penalizing PG&E over Recordkeeping ahead of Fatal September Explosion along Natural Gas Pipeline in San Bruno, California

The California Public Utilities Commission (CPUC) is considering whether Pacific Gas and Electric Company's (PG&E) gas transmission pipeline recordkeeping was unsafe, whether it violated the law, and if so whether deficient PG&E recordkeeping caused or contributed to the pipeline rupture in San Bruno, California on September 9, 2010, CPUC said on February 24. The move follows a conclusion from the National Transportation Safety Board (NTSB) that PG&E incorrectly identified the San Bruno pipe as seamless, when in fact the pipe was seamed and welded. Separately on February 24, CPUC said it planned to use the lessons of the San Bruno disaster to help set new rules for the operation of natural gas pipelines in California. CPUC plans to develop and adopt safety-related changes to its regulation of pipelines, consider ways it can undertake a comprehensive risk assessment for all pipelines under its jurisdiction, and numerous other measures.

Update: El Paso to Open 1.5 Bcf/d, 42-Inch, Wyoming-to-Oregon Ruby Natural Gas Pipeline in July 2011 – Company Had Expected to Open Project in June 2011

Citing weather, the timing of regulatory approvals, and wildlife issues, El Paso Corporation said yesterday that it expected to open the 680-mile Ruby natural gas pipeline in July 2011, or about one month later than previously planned. The company plans to halt constructions in certain parts of western Nevada from March 1 to May 15 to avoid interference with the sage grouse.
