Update: Exelon's 1,134 MW Limerick Nuclear Unit 2 in Pennsylvania at Full Power by March 2

Exelon shut the unit on February 25 "when both the '2A' and '2B' recirculation pumps tripped, the company said previously in a filing with the Nuclear Regulatory Commission (NRC). The NRC reported that on the morning of March 1 the unit was operating at 27 percent.

SCANA Plans about 250 Miles of New 230 kV Transmission Lines in Association with **Expansion at V.C. Summer Nuclear Power Plant in South Carolina**

SCANA Corporation awarded Pike Electric Corporation a contract to construct approximately 250 miles of new 230 kV transmission lines in association with SCANA's jointly-planned expansion at the V.C. Summer Nuclear Station in South Carolina, Pike said on March 2. SCANA's South Carolina Electric & Gas Company (SCE&G) subsidiary and Santee Cooper plan to construct two new units at the facility; the units are expected to be finished in 2016 and 2019.

Oil Prices Rise above \$100/Barrel on Increased Fighting in Libya March 2

WTI crude oil futures surged past \$100 per barrel and gasoline prices rose above \$3 per gallon on March 2 as fighting escalated in Libya and the International Energy Agency (IEA) said that between 850,000 b/d and 1 million b/d of the nation's crude production was offline, multiple news and official sources reported. The spike in prices came despite assurances from the IEA and Shell's CEO that Saudi Arabia and/or other OPEC nations were equipped to compensate for any shortfall in Libyan production. Forces loyal to Libya's leader, Moammar Gadhafi, allegedly took over an important oil installation in the eastern portion of the country overnight, but battles continued near some of the nation's largest oil terminals, as of latest reports. Shipping and trade sources, however, said that at least four tankers – carrying at least 2.4 million barrels of oil – had left Libyan ports over a 24-hour span ended this morning. OPEC production, meanwhile, as a result of the turmoil in Libya, slid from 29.63 million b/d in January 2011 to 29.43 million b/d in February 2011, according to OPEC officials and analysts. http://www.chron.com/disp/story.mpl/front/7452867.html http://online.wsj.com/article/BT-CO-20110302-708348.html

Pipeline Breakage Leads Petrobras to Halt Test Well at Guara Oilfield Offshore Brazil – Field Expected to Produce 120,000 b/d of Oil in Early 2013

Petrobras "temporarily paralyzed" a test well at the Guara oilfield offshore Brazil after an associated pipeline broke, the company said on March 2. There was no spill and Petrobras was investigating the breakage. The company opened the test well in December 2010; it said then that the well would yield 14,000 b/d of oil. The field had been expected to produce 120,000 b/d of oil in early 2013. It was not clear if the pipeline incident would impact that plan.

Update: Abu Dhabi to Begin Crude Deliveries by Mid-2011 along Planned 1.8 Million b/d Oil Pipeline in United Arab Emirates

The pipeline would transport crude oil about 249 miles from Habshan – a key production area – to a terminal in Fujairah, along the United Arab Emirates (UAE) eastern coast, a news source said previously. The line would avoid the Strait of Hormuz. It is expected to ramp up to full operations by early 2012, a source familiar with the situation said this week.

Update: EPA Extends GHG Reporting Deadline beyond March 31, 2011

The U.S. Environmental Protection Agency (EPA) is extending this year's greenhouse gas (GHG) reporting deadline – originally March 31 – in a move that it says will allow it to further test the system that facilities will use to submit data and give industry the opportunity to test the tool, provide feedback, and have sufficient time to become familiar with the tool prior to reporting.
