# Update: All TVA Transmission Lines Return to Service by March 15 following Severe Storms, Tornadoes in U.S. South March 2

The Tennessee Valley Authority (TVA) said Thursday that the last 3 of 15 transmission lines knocked out of service by severe storms earlier this month have been restored. #### Update: NSTAR Restores Power to All Customers in Boston's Back Bay March 16

NSTAR reported Friday that it has restored power to the remaining 4,000 customers in Boston's Back Bay neighborhood who lost power when a transformer fire caused widespread outages Tuesday. Utility repairs caused several manhole covers to explode, knocking out power to some 1,500 customers who had just had their power restored. #### Update: State Supreme Court Reverses Approval of Southern Co. 582 MW Coal-Fired Power Plant in Kemper County, Mississippi

The Mississippi State Supreme Court on Thursday voted unanimously to reverse the Mississippi Public Service Commission's (PSC) May 2010 approval of Southern Co.'s proposed project to build a 582 MW coal-fired power plant in Kemper County, Mississippi. The court said the PSC failed to satisfy state law requiring that the plant benefit the utility's customers, and it sent the case back to the PSC.

On the morning of March 15 the unit was not operating. Exelon Corp. shut Unit 1 March 12 for planned upgrades of the facility's switchyard, including replacing insulators similar to those that failed at the plant in January and February, according to reports.

#### Marathon Reports Pipeline Leak at Its 76,000 b/d Texas City, Texas Refinery March 15

Marathon Petroleum Corp reported a small benzene leak in a pipeline at its Texas City refinery Thursday, according to a filing with the Texas Commission on Environmental Quality. The leak was discovered during pressure testing of the system and was subsequently contained, the filing said. Operators drained the contents of the pipe to begin repairs.

## FERC Approves Sawgrass Storage to Build New 30 Bcf Gas Storage Facility in Louisiana to Serve the Gulf Coast March 15

The Federal Energy Regulatory Commission (FERC) on Thursday approved Sawgrass Storage's plan to construct a new natural gas storage facility in Louisiana to serve markets along the U.S. Gulf Coast. The facility would have 30 Bcf of working gas capacity and firm injection and withdrawal capacities of 300 MMcf/d, providing customers the ability to cycle their inventory up to 1.7 times per year. Construction is slated to start this summer, with a project inservice date of 2013.
