Storms, Strong Winds Knock Out Power to Over 47,000 Westar Energy Customers in Kansas April 2–3

Storms bringing hail and damaging winds hit south-central Kansas overnight, with reported wind gusts up to 89 mph, knocking out power to 47,369 customers. Westar on Friday morning said it was assessing the damage and had crews from Missouri, Arkansas, and Oklahoma to help restore power. As of 3:30 p.m. EDT, 38,202 customers remained without power.

Marathon Petroleum Says Tentative Labor Deals Reached at Refineries in Texas and Kentucky

Marathon Petroleum Corp on Thursday said it had reached tentative labor pacts with the union at its 242,000 b/d Catlettsburg, Kentucky and 84,000 b/d Texas City, Texas refineries. The company also said a labor pact has been ratified at its 80,000 b/d Canton, Ohio refinery. The U.S. Transportation Department (DOT) is completing work on a package of measures to control oil train dangers before the Obama administration finalizes a national safety plan expected by May, an official with knowledge of the plans said on Thursday. U.S. Oil Rig Weekly Decline Smallest Since December 2014 – Baker Hughes

The number of rigs drilling for oil in the U.S. declined by 11 this week to 802, the smallest decline since December 2014, oil services firm Baker Hughes said on Thursday. The data compares with declines of 12 and 41 rigs in the prior two weeks. Energy producers responded quickly to a steep drop in oil prices over the last six months, idling nearly 800 rigs, or 50 percent, since a peak of 1,609 rigs in October. With the decline this week, the number of oil rigs has fallen for a record 17 weeks in a row to the lowest level since 2011, according to Baker Hughes data. Reuters, 13:09 April 2, 2015

Buckeye Partners Announces Successful Open Season for Its Michigan/Ohio Pipeline Expansion Project

Buckeye Partners, L.P. on Thursday announced that one of its operating subsidiaries, Buckeye Pipe Line Transportation LLC, successfully closed a binding open season for its Michigan/Ohio Pipeline Expansion Project. Once complete, the project will allow Buckeye Transportation to offer expanded transportation service of refined petroleum products from origin points in Michigan and Ohio to destination points in Ohio and Western Pennsylvania. The open season closed March 31 and prospective shippers will be notified by April 24, 2015 of their awarded commitments, with fully executed Transportation Services Agreements to follow later in the second quarter of 2015. NuStar Energy Announces Second Binding Open Season for South Texas Crude Oil Pipeline System Expansion Project

NuStar Energy L.P. on Thursday announced the start of the second binding open season of its South Texas Crude Pipeline System expansion. Current construction has resulted in an additional 10,000 b/d of available capacity for firm volume commitment. The season commenced on April 2 and continues until April 23.
