Update: Over 67,000 Customers Remain without Power in Louisiana, Texas April 28 after Strong Storms Hit April 27

Entergy crews continued restoring power Tuesday after strong storms brought wind gusts, tornadoes, large hail, and frequent lightning strikes across Texas and Louisiana Monday morning. As of 3:30 p.m. EDT, 61,552 Entergy Louisiana and 5,955 Entergy Texas customers remained without power, down from a peak of 176,000 Entergy Louisiana and 40,000 Entergy Texas customers. Entergy Louisiana said it expects to restore power to most customers later this evening. The company reported impacts to 19 substations and 82 transmission line segments, and estimated 300 damaged utility poles needed replacement. Entergy Texas said the estimated restoration time for some of the most heavily damaged areas is Wednesday by noon.

Kauai Island Utility Cooperative Reports Rolling Blackouts Due to an Unplanned Generator Outage in Hawaii April 27

The Kauai Island Utility Cooperative reported rolling blackouts for approximately 30 minutes to 12,000 customers on the island of Kauai because of a generator outage on Monday. The company said its second largest generator went offline due to a mechanical issue while their main generator was already offline due to scheduled maintenance. Fire Erupts along Hydrogen Pipeline at MarkWest's Meter Station in Citgo's 163,000 b/d Corpus Christi, Texas refinery April 28

A fire broke out at a meter station run by MarkWest Energy Partners' at Citgo's 163,000 b/d Corpus Christi, Texas refinery, according to an alert issued by the Corpus Christi/Nueces County Local Emergency Planning Committee. As of 3:30 PM EDT local media reported fire crews were on site depressurizing the affected line, that most of the fire had been extinguished, and the hydrogen leak was close to being contained. MarkWest runs the Javelina gas processing and fractionation facility in Corpus Christi, Texas, which processes exhaust gases from six local crude oil refineries for industrial use.

Enbridge, TransCanada, Kinder Morgan Working to Evaluate Aerial-Based Pipeline Leak **Detection Technologies**

Enbridge Pipelines Inc., TransCanada Corporation, and Kinder Morgan Canada signed a Joint Industry Partnership (JIP) agreement to conduct research into aerial-based leak detection technologies, in the interest of enhancing across-the-board pipeline safety. The goal of the project is to identify technologies capable of viably detecting small leaks from liquid petroleum pipeline systems to improve pipeline safety. The project is expected to involve laboratory research and field trials to evaluate the feasibility of commercially viable technologies for use with crude oil and hydrocarbon liquids pipelines. The partnership includes funding commitments from all three companies. Pembina Places 50,000 b/d Peace Pipeline Expansion into Service in Alberta April 24

Pembina Pipeline Corporation on Monday announced that it placed its Phase II low vapor pressure (LVP), crude oil and condensate pipeline expansion (Phase II LVP Expansion) into service. The Phase II LVP Expansion, which is underpinned by long-term contracts with Pembina's customers, adds an incremental 55,000 b/d on the company's Peace Pipeline System, bringing total line capacity to over 250,000 b/d.
