### Update: San Diego Approves SDG&E's Plan to Prevent Wildfires in California

San Diego Gas & Electric (SDG&E) plans to temporarily disconnect electricity service in rural areas of San Diego County starting September 1, when extreme weather conditions create a high risk of wildfires. The company proposed the shutoff plans following state investigations that concluded SDG&E's power lines snapped due to high winds and sparked wildfires in 2007.

# Shell's 20-Inch, 173,000 b/d Eugene Island Crude Pipeline in Gulf of Mexico Shut after Leak July 27

The pipeline was shut to repair a leak which spilled 1,400 barrels of crude into the Gulf of Mexico offshore Louisiana. The cause of the leak is under investigation. The unit was shut after an electrical breaker tripped offline. The outage had no impact on refinery production. Reuters, 17:36 July 27, 2009

#### Valero Shuts Coker at its 315,000 b/d Corpus Christi, Texas Refinery

The 20,000 b/d coker has been shut due to poor economics. The decision comes as Valero shifted its crude slate at the refinery to lighter crudes as the discount for heavy crude disappeared. Valero previously announced reductions at other refineries.
