### **SCE Reports Minor Outages, Substation Fire in California Due to Earthquake July 29**

Southern California Edison reported that its transmission and generation systems were operating normally July 29 after a 5.4 magnitude earthquake struck near Chino Hills, California but an estimated 5,000 customers near the earthquake's epicenter lost power. SCE expected to have all customers restored by late July 29. A fire also occurred at SCE's substation in La Habra but no major damage was reported. The earthquake was felt at SCE's San Onofre Nuclear Generating Station site but there were no safety issues reported and no indications of any damage.

### **Update: Southern's 830 MW Farley Nuke Unit 1 in Alabama Ramps Up to 30 Percent by July 30**

The Nuclear Regulatory Commission reported that on the morning of July 29 the unit was not operating. The unit was shut down on July 22 to make repairs to a diesel generator.

### **Kinder Morgan Shuts 7 Product Pipelines in California Due to Earthquake July 29 All But One Restarted by Late July 29**

According to a Reuters report, Kinder Morgan shut seven petroleum product pipelines as a precaution due to a 5.4 magnitude earthquake near Chino Hills, California, but restarted all but one of the lines by late July 29. The one line that did not restart on July 29 remained shut early July 30 as the company undertook pressure testing. A company spokesman said that no leaks or damage had been detected and the line was expected to return to service soon.

According to an OPIS report, the shut line runs from Colton to San Diego, California.

## **Power Outage Shuts Several Units at Irving Oil's 300,000 b/d St. John, New Brunswick Refinery July 29**

According to a company spokeswoman, the refinery is running at "slightly reduced capacity" after a lightning strike outside the refinery property cut power to the facility late July 29. Traders say that one of two crude units and several downstream units were shut. Local media reported that the power outage caused two flange units to leak gasoline and diesel fuel. According to the reports, one of the flanges caught fire but was quickly extinguished. The Irving Oil spokeswoman said that some units at the refinery had already been restarted early July 30 and that the company expected to restart the rest of the units by the end of July 30. This was the second power outage in less than a week at the refinery.

## **Infrastructure Security Brings Stability to Iraq's Oil Sector – Report**

According to a quarterly report released by the U.S. Defense Department's Inspector General for Iraqi Reconstruction, Iraqi oil production set new records this quarter, with output reaching 2.43 million b/d, the highest quarterly average since the 2003 invasion. The report attributes this increase, in part, to improved security across Iraq and, in particular, to the success of the U.S.-funded Pipeline Exclusion Zone (PEZ) program. The Kirkuk-to-Baiji PEZ project produced a system of ditches, berms, fences, and concertina wire protecting oil pipelines, all of which are secured by Iraqi security force personnel. As a result of the enhanced security measures, there have been no successful attacks on oil pipelines in Iraq this year.

## **China Threatens ExxonMobil Over Oil Deal with Vietnam in South China Sea**

A Hong Kong newspaper says that Chinese diplomats have threatened retaliation if ExxonMobil goes ahead with a preliminary agreement with the Vietnamese state oil company PetroVietnam to exploit oil deposits in the South China Sea off Vietnam's south and central coasts. China claims a large portion of the South China Sea. Vietnam has indirectly responded that its agreement is in force and will proceed.

### **Enterprise Shuts Independence Pipeline for Four Days to Evaluate Repairs July 29**

The company shut its 1 Bcf/d Independence Pipeline around 9:00 PM CDT, July 9, for about four days to evaluate previous repairs. The pipeline, which gathers natural gas from 15 wells in the eastern-most producing area of the Gulf of Mexico, was shut after a leak was detected on April 9, and did not reopen until repairs were completed 55 days later.

## **Other News**

### **Update: U.S. Coast Guard Closes 2 Miles of Mississippi River after More Oil Spills from Disabled Barge**

On July 30, the U.S. Coast Guard announced that it had temporarily closed two miles of the Mississippi River near New Orleans as a precautionary measure after a secondary fuel spill from a barge disabled by a collision last week. The damaged barge, DM 932, shifted with dropping river levels and released an unknown amount of additional oil. During the closure, no vessels are allowed to pass along the two-mile stretch. At the time of the secondary spill, a 98-mile stretch of the Mississippi River remained an "existing safety zone", meaning that vessels are allowed to transit the river with increased caution and at reduced speeds. On July 29, the Coast Guard reported that a backlog of vessels waiting to transit the 98-mile stretch had been reduced, and deep draft movement was approaching normal flows.
