Strong Storms Knock Out Power to 18,000 NorthWestern Energy Customers in Montana August 10

Strong storms knocked out power to 18,000 NorthWestern Energy customers in the Missoula and Bitterroot valleys of Montana on Monday evening. There were reports of downed power lines around the region, including major power transmission lines. As of 12:30 p.m. EDT on Tuesday, 8,000–9,000 customers remained without power and the company said it was bringing in additional crews to aid in restoration efforts. https://twitter.com/NorthWestern MT

Valero Plans Hydroplex Restart at Its 180,000 b/d Memphis, Tennessee Refinery August 13 – Source

Valero Energy Corp planned to restart the hydroplex at its Memphis, Tennessee refinery by Thursday night after completing unplanned repairs, sources familiar with plant operations said on Monday. The hydroplex was knocked out of production on August 2. In addition, the refinery cut production last week due to unit outages and disruptions, according to sources.

Phillips 66 Fixes Compressor at Its 336,000 b/d Wood River, Illinois Refinery August 11 – Source

Phillips 66 resolved a problem with a compressor at its refinery in Wood River, Illinois and the facility was running normally, according to a person familiar with the refinery's operations. Workers were preparing to shut a 120,000 b/d crude unit for up to five weeks in early September.

LOOP to Expand Clovelly Hub Crude Oil Storage by 1.1 Million Barrels

Louisiana Offshore Oil Port (LOOP) on Monday announced it was expanding Clovelly Hub's aboveground storage capacity by more than ten percent. The construction of three new aboveground storage tanks will add 1.1 million barrels of crude oil storage at the Clovelly Hub in South Louisiana. The project completion is set for late summer 2016. Upon completion, crude oil capacity at the Clovelly Hub will increase to over 70 million barrels. The new tanks will join 15 other crude oil storage tanks now in operation at the Hub and bring total capacity of aboveground storage to 10.1 million barrels. Additionally, 60 million barrels of capacity comprise the underground storage operation at the Hub.

Update: Alliance to Restart Its 1.6 Bcf/d Mainline Pipeline to Chicago, Illinois August 12, Expects to Lift Force Majeure August 13

Alliance Pipeline said it would restart on Wednesday the pipeline that carries natural gas from Western Canada to Chicago. The company shut the pipeline on August 7 after poisonous, flammable gas got into the system, forcing at least five producers to curb output and lifting Chicago prices. The company also said it expected to lift force majeure and resume full contract firm service on Thursday.

American LNG Receives DOE Approval for Non-FTA LNG Exports

The U.S. Energy Department (DOE) issued a final authorization to American LNG to export domestically-produced liquefied natural gas (LNG) to countries that do not have a free-trade agreement (FTA) with the U.S., officials announced on Monday. Under the agreement, American LNG is authorized to export LNG up to the equivalent of 0.008 Bcf/d of natural gas for a period of 20 years from the liquefaction facility located near Medley, Florida using approved ISO LNG containers. Federal law generally requires approval of natural gas exports to countries that have an FTA with the U.S. For countries that do not have an FTA with the U.S., the Natural Gas Act directs DOE to grant export authorizations unless the department finds that the proposed exports "will not be consistent with the public interest." Update: Libya's El Feel, El Sharara Oilfields Remain Closed – Oil Officials

Libya's El Sharara and El Feel oilfields remain closed due to protests and a pipeline blockage, oil officials said on Monday. Tribal elders have been trying for months to resume work at both fields, which could add some 400,000 b/d of crude oil, doubling Libya's current output. An oil source at the western Zawiya port linked to the El Sharara oilfield said there were efforts to reopen the 340,000 b/d field, but so far there was no breakthrough. An engineer at El Feel also said there was no sign of output resuming.
