# Update: NRC Blames TVA for Last Year's Valve Failure at 3,440 MW Browns Ferry Nuclear Plant in Alabama August 17

According to previous reports, the Nuclear Regulatory Commission (NRC) issued a "red" rating to the Tennessee Valley Authority (TVA) in May due to an October 23, 2010 incident in which a valve failed to open at the plant. The NRC rejected TVA's appeal of the red rating in June. On August 17, the NRC announced that TVA had had opportunities to fix the problem before the valve failed, and that TVA's failure contributed to the performance deficiency.

#### Mexico to Allow Private Investors to Develop State-Owned Oil Fields in Three Phases

The Supreme Court of Mexico lifted a seven-decade ban on private investment in state-owned oil fields in December 2010. Mature onshore oil fields will be offered during the first phase of opening these fields to foreign oil companies. In the second and third phases, shallow and deep water Gulf of Mexico fields will be offered respectively. Private companies are expected to produce up to 25,000 b/d by 2012.

### DCP Midstream Plans 720-Mile, 20-Inch, 200,000 b/d Sand Hills NGL Pipeline in Texas August 18

The company announced today that its board of directors has approved the construction of the pipeline, which would transport natural gas liquids (NGLs) from the Permian and Eagle Ford basins to the Texas Gulf Coast. The pipeline would have an initial capacity of 200,000 b/d, though it could be expanded to 350,000 b/d. Noble Energy reported that its acreage in the area is estimated to contain 7.4 trillion cubic feet equivalent-risked resources, of which 400 billion cubic feet equivalent were proven reserves at the end of 2010. Net production to Noble Energy's interest has the potential to reach 600 MMcfe/d in 2015 and is expected to continue growing into the next decade.
