Exelon shut the unit to replace a damaged pipe segment, a news source reported. The source did not say when the unit might return to service. The Nuclear Regulatory Commission reported that on the morning of September 8 the unit was operating at full power.

NRC to Assess Efficacy of Leak-Detection Programs at U.S. Nuclear Power Facilities

The U.S. Nuclear Regulatory Commission (NRC) asked its staff to assess the effectiveness of current leak-detection programs, and make suggestions for possible improvements, agency officials said. Several nuclear power facilities—including the Oyster Creek facility in New Jersey and the Indian Point site in New York—have sustained underground pipe leaks this year, a source said.

Shell restarted a crude unit over the weekend at its 156,400 b/d Martinez, California refinery, according to sources familiar with the facility's operations. Operators shut the crude unit and a flexicoker in mid-July for an expected month of maintenance, but extended the downtime for unspecified reasons. The flexicoker remained offline, as of latest reports.

Russia Increases Oil Exports despite OPEC Reductions

Russia exported 7.4 million b/d of oil in the second quarter of 2009—up from 7.25 million b/d in the first quarter—outpacing Saudi Arabian crude exports for the first time since the Soviet Union's collapse, sources said. Saudi Arabia exported 7 million b/d, from 7.39 million b/d in the previous quarter, the International Energy Agency (IEA) said. The Russian increase came in spite of previous officials' statements that the nation planned to slash its crude production in line with OPEC cuts.
