Explosion, Fire Due to Construction Activity Reported at GRDA's 594 MW Coal-fired Unit 2 in Oklahoma October 18

The job site at the Grand River Dam Authority (GRDA) Power Station in Mayes County was shut down indefinitely while officials investigate an explosion and fire that left three people injured on October 18. The incident was a result of a construction-related activity at the plant's unit 2 coal-fired generator. There was no structural damage to the plant and the cause is still under investigation, a GRDA spokesperson said.

Oasis Petroleum Plugs Oil Well in North Dakota October 20 after Blowout October 17

Oasis Petroleum Inc said on Tuesday that it successfully plugged a blow out in North Dakota after losing control of a well late Saturday evening, which leaked more than 67,000 gallons of oil as well as brine and natural gas. On Tuesday, Oasis crews pumped more than 33,000 gallons of a bentonite clay and water mixture down the well to permanently plug it and prevent the uncontrollable outward flow of liquids. A light sheen was observed on the White Earth River and containment booms were deployed to prevent hazardous liquids from migrating downstream to the Missouri River. Personnel from the North Dakota Oil and Gas Division and Department of Health are on site and continue to monitor the situation.

Update: Coast Guard Reopens North End of Houston Ship Channel with Restrictions October 19

The Coast Guard said it reopened the north end of the Houston Ship Channel with some restrictions late Monday, after transportation along a five-mile section was impacted by a sunken sheet metal barge and tow boat early on Monday morning. The sinking took place near the Kinder Morgan docks, located across the channel from where Vince Bayou enters the channel. According to the Coast Guard, salvage operations are underway to remove the sunken vessels and to survey the channel for obstructing sheet metal debris. All vessel movements through the channel between Kinder Morgan docks 2 and 4 are currently subject to reduced speed restrictions until the salvage operations are complete.

Barge Traffic Stalled as Boats Run Aground on Mississippi River in Illinois - Coast Guard

The Coast Guard closed a section of the upper Mississippi River to commercial traffic over the weekend for emergency dredging operations after a tow boat ran aground in low water near Quincy, Illinois, on Saturday. The closure, from mile marker 330.7 to 330.9, is expected to remain in place until at least Wednesday as the U.S. Army Corps of Engineers dredges the river to deepen the waterway, a Coast Guard spokesman said. At least a dozen barge tows were waiting to pass on Monday afternoon, he said. The Mississippi River is a major waterway for the transportation of petroleum products between PADDs 2 and 3. Kinder Morgan, BP Form Joint Venture Company to Purchase U.S. Terminals from BP

Kinder Morgan Inc today announced that it finalized agreements with BP Products North America Inc to acquire 15 refined products terminals and associated infrastructure through a joint venture (JV) terminal business. Kinder Morgan will gain sole ownership rights of a single terminal and operate the remaining terminals on the JV's behalf. In return, BP will enter into commercial agreements to secure long-term storage and throughput capacity from the JV. The terminals, with approximately 9.5 million barrels of storage, are pipeline-connected to key refining and processing centers across the U.S. and offer extensive truck, vessel, and barge access and terminal service capabilities. The transaction is expected to close in the first quarter of 2016.

Update: Lewis Energy Says Its West Texas Facility Remains Shut October 20 after Natural Gas Pipeline Fire October 16

Lewis Energy Group said gas flow to its West Yard facility near Encinal, Texas remained shut following a fire on a natural gas pipeline within the site on October 17. About 25 percent of production volumes have been shut in due to the fire, the company said on Monday, adding that the current focus of the investigation into the incident is on a separator unit within the facility. Lewis Energy said it was reviewing options for rebuilding the affected facility, which could take several months.
