#### DTE's 1,089 MW Fermi Nuclear Unit 2 in Michigan Shut by October 25 after Turbine Trip on October 24

According to a company filing with the Nuclear Regulatory Commission (NRC), the unit experienced a main turbine trip due to a loss of condenser vacuum October 24. The NRC reported that on the morning of October 24 the unit was operating at 97 percent.

#### BrightSource to Break Ground on Proposed 392 MW Ivanpah Solar Electric Generating System in California October 27

The solar thermal plant will be the largest in the world, and the first large scale project of its type in California in more than two decades. Thousands of mirrors will concentrate the sun's rays to produce steam which will in turn power three turbines to produce up to 392 MW of electricity. #### Multiple Units Malfunction at ConocoPhillips' 280,000 b/d Bayway Refinery in Linden, New Jersey October 21-25

A gasoline-making unit was operating at reduced rates October 22 after an unplanned compressor shutdown October 21, but the unit was expected to return to normal rates by October 23. In an unrelated event, a transformer malfunctioned on October 25, leading to a power outage and flaring. Part of the refinery is currently shut for planned maintenance. It is not clear if either event had an effect on the refinery's output.

#### Update: Enbridge Extends Open Season for Proposed 145,000 b/d Bakken Expansion Program in North Dakota and Saskatchewan, Canada until November 30

Enbridge Energy Partners L.P. and Enbridge Income Fund launched a binding open season on August 26 for its proposed Bakken Expansion Program, a series of projects intended to expand crude oil pipeline capacity in North Dakota and Saskatchewan. The project would provide 145,000 b/d of incremental pipeline capacity from new receipt locations in the Bakken and Three Forks formations in North Dakota to interconnections with other existing Enbridge systems. The open season was expected to end on October 29. Enbridge currently has enough binding commitments to allow construction to proceed, though some customers requested additional time to secure necessary approvals to make a commitment to use the new facilities.

# Update: Tenth Oil Refinery in France Begins to Shut by October 25 as Strikes Limit Crude Oil Supplies

Ineos AG began to halt production at its 218,000 b/d Lavera refinery due to a lack of crude oil supplies according to a company representative. French riot police took over Total's 93,000 b/d Grandpuit refinery on October 22 after it had been blockaded by protestors. France's 11 operable refineries have a total capacity of 1.84 MMb/d according to Bloomberg.

#### Ecopetrol Declares Commercial Viability at Its 1,600 b/d Casabe Sur Field in Colombia October 21

Ecopetrol plans to increase production at the field to 5,500 b/d by 2012. It is estimated that the field contains 62 million barrels of hydrocarbons, of which unaudited proven oil reserves are calculated to be 5.4 million, with 9.9 million barrels of probable reserves.

#### DOT, EPA Propose First-Ever Fuel Efficiency Standards for Heavy Trucks October 25

The proposed rules would cut carbon emissions by 20 percent by 2018. The first-ever fuel efficiency rules for commercial vehicles, they would affect model years 2014 to 2018. The Department of Transportation and the Environmental Protection Agency estimate that the new rules would eventually save 500 million barrels of oil over the life of the new trucks.
